



FINGAL DEVELOPMENT PLAN 2011 - 2017

Section 20 (1) of the Planning & Development Act 2000 requires The Planning Authority to consult with the public before preparing a Local Area Plan.

The County Council now intends to prepare the

Donabate Local Area Plan, 2012-18

The future LAP will focus on undeveloped lands which are zoned Objective RA - 'Provide for new residential communities in accordance with approved local area plans and subject to the provision of the necessary social and physical infrastructure' comprising approx. 144 hectares (355 acres) in four land parcels:

At Corballis - south of the village and north of the Broadmeadow Estuary	65.6 ha
At Ballymastone - east of the village	56.7 ha
North of the village at Rahillion	5.5 ha
West of the village at Turvey Avenue	16 ha

Among the key issues to be addressed in the plan are:

- Integration of the new development areas with the established Village of Donabate
- Appropriate density, mix and quantum of development for the zoned residential lands
- Urban design and landscaping framework
- Movement systems for pedestrians, cyclists and vehicles in Donabate
- Provision of Environmental and Infrastructural Services
- Provision of Community and Recreational Amenities
- Climate change, sustainability, energy and waste management
- Protection of the adjoining sensitive coastal environments

Strategic Environmental Assessment (SEA):

The Local Area Plan lands will be assessed having regard to SEA Directive (2001/42/EC) and the Planning and Development (Strategic Environmental Assessment) Regulations 2004 (as amended).

Appropriate Assessment:

Appropriate Assessment Screening pursuant to Article 6 of the EU Habitats Directive 92/43/EEC will be undertaken for the plan lands.
