In accordance with section 42 of the Planning and Development Act, 2000 and Regulations made thereunder, a Planning Authority shall extend a permission as appropriate provided that the application is made in accordance with regulations made under the Act and the Authority are satisfied in relation to the permission that:-

Important Notes:

The power to extend the appropriate period shall not apply to the grant of an OUTLINE PERMISSION granted under S. 34 of the Planning and Development Act, 2000.

In all cases, even for Outline Permission/Permission granted under the Local Government (Planning and Development) Acts 1963 - 1993. Substantial works must have been carried out and application to extend or further extend the appropriate period must be made, BEFORE the end of the appropriate period.
